Mr. Kovit then asked the Board if there was a motion to adjourn the public hearings until the November meeting. A motion was made by Chairman Siniscalchi, seconded by Commissioner Baessler, to adjourn the two public hearings to the November meeting.

Case # 18346 Michael Kadoe, 85 Erie Avenue

Construct a 4'-6 1/2" x 19'-5 1/2" rooftop bulkhead

Mr. Kadoe asked the Board if they would consider having a special meeting prior to the scheduled date of the November meeting, so that his case could be heard more expeditiously. He observed that his application has been pending for awhile. Upon questioning from Mr. Kovit, Building Inspector Cherson assured Mr. Kadoe and the Board that the rooftop bulkhead area is sufficiently secured from the elements, and no prejudice would be suffered by Mr. Kadoe if the hearing is held on November 15th.
