PUBLIC HEARING TO AMEND THE CODE OF THE VILLAGE OF ATLANTIC BEACH

Superintendent of Public Works/Building Inspector Steve Cherson explained each of the following local laws and answered any questions from the public.

LOCAL LAW 3-2017: Chapter 235 - Vehicle and Traffic

§ 235-57. Schedule XII: Parking Prohibited at all times

Eldorado Street East Side Delete: 205' north of Pacific-Atlantic

Change to: 140' north of Pacific

§ 235-60. Schedule XV: Prohibited Parking Certain Hours

Eldorado Street East Side 10 am to 5 pm - May 15 to Sept 15

140' north of Pacific - Atlantic

West Side 10 am - 5 pm

200' north of Pacific-Atlantic

§ 235-64. Schedule XIX: Angle Parking.

In accordance with the provisions of § 235-23, no person shall park a vehicle upon any of the streets or parts—thereof described below, except at the angle designated:

§ 235-68. Schedule XXIII: Handicapped Parking.

Editor's Note: Handicapped parking signs should read, "Handicapped Parking with VAB Sticker Only" at Eldorado Beach, The Plaza Beach, Genesee Beach and Putnam Beach, according to the resolution adopted 1-11-1999 and amended 8-23-1999. Two handicapped parking spots were removed in front of the Eldorado Beach entrance 5-29-2001. In accordance with the provisions of § 235-44, the following described locations are hereby reserved for vehicles bearing the window sticker issued by the Coordinator of the Nassau County Council to Aid the Handicapped:

LOCAL LAW 4-2017: Chapter 65 - Beaches, Boardwalks and Recreation Areas-

Prohibited Acts: Smoke Free Beach

ARTICLE II - USE OF PARK PROPERTY AT BEACHES SECTION 65-4 - PROHIBITED ACTS - NEW SUBSECTION: N

N. No person shall be in physical possession of a lighted cigarette, cigar or pipe on the boardwalk or beach areas of the Village of Atlantic Beach as defined in this Chapter. The requirement shall be in addition to all other

applicable smoking-related regulations enacted by any other level of government with jurisdiction, and shall not be construed as making anything legal which would otherwise be unlawful under regulations. This prohibition shall not include any battery-operated e-cigarette or similar electronic device which does not burn tobacco.

LOCAL LAW 5-2017:

Chapter 200 - STREETS AND SIDEWALKS

Article I - Construction, Repair and Maintenance

§ 200-4 Concrete construction required; exceptions.

A. Curbs and sidewalks on streets or other public rights-of-way shall be constructed of concrete.

- B. The Board of Trustees may permit curbs to be constructed of materials other than concrete if it is deemed that the proposed construction is safe and will not provide a hazard to the public and can be kept clean and maintained.
- C. Any sidewalk, curb, apron or gutter to be replaced or repaired by the Village or its agents shall be constructed of concrete regardless of the material previously approved by permit. Property owners that want in-kind material replaced shall be responsible for the cost, except sidewalks shall remain concrete.
- D. Construction requirements to install.
- (1) One-course sidewalks to a minimum four thousand (4000) psi shall be cast between forms and constructed to a minimum thickness of four (4) inches, except at commercial area sidewalks, in which case the sidewalk shall be five (5) inches thick. Any sidewalks under traffic-bearing areas, such as a drop curb, apron and a driveway or parking lot, shall be six (6) inches thick, and reinforced with galvanized 6x6-W1.4 W1.4 WWM. Concrete aprons at drop curbs shall be 4000 psi, six (6) inches thick, and reinforced with galvanized 6x6-W1.4 W1.4 WWM. All sidewalks shall be a minimum of four (4) feet wide. All or as approved by the Building Inspector. All handicap drop curb ramps shall be installed as per ANSI 117.1 standards.
- (2) One-course curbs shall be cast between forms at four thousand (4000) psi strength and shall have the following dimensions: six (6) inches across the top, eight (8) inches across the bottom, and not less than 18 inches in depth. The top of the curb shall be pitched toward the street and six (6) inches above the gutter/street grade or water line grade. The back of curb shall be vertical and the face of curb shall have a batter of two (2) inches in 18 inches toward the street. At driveways, the top of curb shall be dropped to within 3/4 inch to 1 1/4 inches of the gutter/street grade or water line grade. New drop curbs/curb cuts shall be a minimum of two (2) feet away from property lines and a maximum of 20 feet wide. #5 rebar continuous except through expansion joint. All or as approved by the building inspector.
- (3) Expansion joints. The curbs, gutters and combined curbs and gutters shall be cut into sections not longer than twenty (20) feet and shall be provided with one-half-inch expansion joints every fifty (50) feet at the ends of all curves.

Article II: Excavations

200-6.1 Construction requirements to restore.

A. Openings on Newly Constructed or Resurfaced Roads.

No excavation shall be permitted on any newly constructed or resurfaced highway for a period of not less than five years. This subsection does not include any excavation on the right-of-way abutting said newly constructed or resurfaced highway. Should such an opening be required for emergency purposes, permission must be obtained from the Building Department and restoration plans reviewed and approved by the Superintendant of Public Works

B. Restorations.

(1) All restorations shall be cut back a minimum of twelve (12) inches on each side of the excavation as necessary to avoid ragged edges on the restored area. The area

to be restored shall be increased as necessary to avoid residual strips of existing pavement of less than three (3) feet in the smaller dimension.

(2) Work must commence within thirty (30) days from the date of the permit and be satisfactorily restored within ninety (90) days thereafter unless otherwise extended, in writing, by Public Works Department.

C. Construction Requirements

All procedures and materials shall be in conformance with the latest edition of the Nassau County Specifications for Construction of Highways and Bridges and the Nassau County Traffic Signal Specifications as prepared by the Nassau County Department of Public Works.

D. Pavement Restoration Specifications.

- (1) Bituminous-type pavement
- (a) One and one-half (1 1/2) inches minimum compacted asphalt concrete Type 1A, Item 36SS, two (2) inches minimum compacted dense-graded base course asphalt concrete Item 36DX-M, Five (5) inches minimum compacted dense-graded aggregate base course Item 398 (RCA), all edges of restored pavement shall be sealed with hot asphalt cement a maximum width of two and one-half (2 1/2) inches.
 - (2) Concrete pavement
- (a) Where existing pavement is reinforced or contains joint supports, the removal of the pavement shall be performed in such a manner as to allow projection of six (6) inches of the reinforcement and the undisturbed joint supports into the replacement area. If such is not feasible, the permittee shall indicate proposed corrective measures for approval by the Commissioner. Replacement concrete shall be Type II and entrained with additives such as will assure compressive strength cores of four thousand five hundred (4000) pounds per square inch in forty-eight (48) hours. The concrete shall be of the same thickness as the adjacent undisturbed concrete. With the approval of the Building Department, asphalt concrete base may be used as a replacement for adjacent concrete base on longitudinal cuts only. Where asphalt concrete is used, it shall be two (2) inches thicker than the concrete it replaces.
 - 1. Longitudinal openings
 - a. The entire panel width must be removed and replaced. Ends of panels must be saw cut if not at a transverse joint.
 - b. In no case shall any portion of the existing panel that is less than six (6) feet from a transverse joint be left in place.
 - c. When concrete base panels with asphalt overlays are to be removed, the asphalt shall be cut back a minimum of six (6) inches onto the adjacent panels to provide a smooth vertical edge.

2. Transverse openings

- a. Transverse openings shall be saw-cut ninety degrees (90°) to the longitudinal joints.
- b. Pavement replacement shall be a minimum of two (2) feet on both sides of the trench and a total minimum of six (6) feet wide by the width of the panel.
- c. In no case shall any portion of the existing panel that is less than six (6) feet in length from a transverse joint of existing crack be left in place.
- d. Where openings are skewed across the pavement, the concrete replacement must be carried straight across each panel and not staggered.

LOCAL LAW 6-2017:

CHAPTER 230 - VEHICLES: ABANDONED, PARKED, COMMERCIAL OR STORED SUBSECTION 230-1: INOPERATIVE AND UNLICENSED VEHICLES;
PAINTING OF VEHICLES

A: Except as provided for in statute or other regulations, no inoperative or unlicensed motor vehicles shall not be parked, kept or stored on any premises, and no vehicle shall at any time be in a state of major disassembly or disrepair, or in the process of being stropped or dismantled. Painting of vehicles is prohibited unless conducted inside an approved spray booth.
