#### PUBLIC HEARING TO ADOPT LOCAL LAW 1-2023 TO AMEND THE CODE OF THE VILLAGE OF ATLANTIC BEACH CHAPTER 200 - STREETS AND SIDEWALKS

A Local Law to Amend the Code of the Incorporated Village of Atlantic Beach Chapter 200 entitled "Streets and Sidewalks"

Be it enacted by the Board of Trustees of the Incorporated Village of Atlantic Beach as follows:

Section 2. Chapter 200 entitled "Responsibility of owner or occupant" is hereby replaced with the following language:

"Sidewalks and curbs to be kept clean and in good repair. Every owner or occupant of any house or other building, and every owner or person entitled to possession of any vacant lot, and every person having charge of any public building in the Village, shall keep the sidewalks in front of such house, building or lot, free from obstruction by snow or ice and shall, also at all times, keep such sidewalks and curbs in good and safe repair and clean, and keep the same free from dirt, filth, hedges and woods or other obstruction or encumbrance and such owner or occupant shall cause the sidewalks in front of such house, building or lot to be cleared of snow within 24 hours after such snowfall shall have ceased and every owner or occupant of any house, building or lot shall be solely liable for any claim for property damage or bodily injury on the sidewalk, including the defense and indemnification of the Village against such claim.

#### Section 2. Full Force & Effect.

Except as hereinabove amended, Chapter 200 shall remain in full force and effect.

#### Section 3. Repealer.

All ordinances, local laws or resolutions, or parts of ordinances, local laws or resolutions of the Incorporated Village of Atlantic Beach inconsistent with the provisions of this local law are hereby repealed, provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this local law shall be in addition to other legislation regulating and governing the subject matter covered by this local law.

# Section 4. Severability.

If any section, paragraph, subdivision or provision of this local law shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this local law as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

#### Section 5. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of the State of New York.

## VILLAGE OF ATLANTIC BEACH

COUNTY OF NASSAU

A local law to amend Chapter 210 of the Code of the Village of Atlantic Beach – Taxation Article IV- Section 210.24 to authorize an override of the tax levy limit established in General Municipal Law §3-c

#### Section 210.24. Legislative Intent

It is the intent of this local law to allow the <u>Village of Atlantic Beach</u> to adopt a budget for the fiscal year commencing <u>June 1, 2023</u> that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

#### Section 210.25. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

#### Section 210.26. Tax Levy Limit Override

The Board of Trustees of the Village of <u>Atlantic Beach</u>, County of <u>Nassau</u>, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2023 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

#### Section 210.27. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 210.28. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.
