PUBLIC HEARING TO ADOPT LOCAL LAW TO AMEND
CHAPTER 165 – PROPERTY MAINTENANCE – SPRINKLER SYSTEMS ON VILLAGE PROPERTY

Local Law No: \_\_ of the year 2024

Village of Atlantic Beach, County of Nassau

A Local Law to Amend the Code of the Incorporated Village of Atlantic Beach Chapter 165 entitled "Property Maintenance" to add a subsection 165-2.2 regarding sprinkler systems.

Be it enacted by the Board of Trustees of the Incorporated Village of Atlantic Beach as follows:

Section 1. Section 165-2.2 is hereby added with the following language:

§165-2.2. Sprinkler systems

Any Sprinkler heads or parts of the system installed or maintained on property of the Village shall be the responsibility of the property owner. This shall include any damage caused by construction of roadways, sidewalks, curbs and aprons by the Village.

Section 2. Full Force & Effect.

Except as hereinabove amended, Chapter 165 shall remain in full force and effect.

Section 3. Repealer.

All ordinances, local laws or resolutions, or parts of ordinances, local laws or resolutions of the Incorporated Village of Atlantic Beach inconsistent with the provisions of this local law are hereby repealed, provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this local law shall be in addition to other legislation regulating and governing the subject matter covered by this local law.

Section 4. Severability.

If any section, paragraph, subdivision or provision of this local law shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this local law as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

Section 5. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of the State of New York.

Local Law No: \_\_ of the year 2024 Village of Atlantic Beach, County of Nassau

A Local Law to Amend the Code of the Incorporated Village of Atlantic Beach Chapter 250 entitled "Zoning" to add definitions of Motorized Equipment and Lot, Through to section 250-1; amend the requirements for area maps in section 250-93; remove sections 250-25 (A)(7), 250-25 (A)(8) regarding location of HVAC equipment and generators; add section 250-108(P) and section 250-108(Q) regarding location of HVAC equipment and generators; add section 250-74 (N) regarding structures in front and side yards; add section 250-74(O) regarding motorized equipment under the boardwalk, and remove section 250-118 regarding clear site triangles.

Be it enacted by the Board of Trustees of the Incorporated Village of Atlantic Beach as follows:

Section 1. The following definitions are added to section 250-1 entitled "Definitions" in alphabetical order:

# PUBLIC HEARING TO ADOPT LOCAL LAW TO AMEND CHAPTER 250 ZONING – MOTORIZED EQUIPMENT, AREA MAP, HVAC (Continued)

#### LOT, THROUGH

A lot extending from one street through to another street. Where a lot extends through from street to street, the applicable front yard and distance from street regulations shall apply on both street frontages, both street right-of-way lines shall constitute front lot lines, and neither street right-of-way line shall constitute a rear lot line. [Added 7-8-2024 by L.L. No. \_\_-2024]

#### MOTORIZED EQUIPMENT

Equipment or devices powered by internal combustion, hydraulics, pneumatics, electricity or mechanical means. [Added 7-8-2024 by L.L. No. \_\_-2024]

Section 2. Section 250-93 Area Map to be included with certain applications is hereby replaced with the following:

[Amended 3-9-2009; 3-9-2020 by L.L. No. 2-220; 7-8-2024 by L.L. No. \_\_-2024] Every application to the Board of Trustees for an amendment of the Building Zone Ordinance or of the Building Zone Map or for a site plan approval, and every application to the Board of Zoning Appeals for an appeal, variance or special exception, shall be accompanied by an area map prepared by a professional engineer or surveyor licensed by the State of New York showing by courses and distances the property which is the subject of the application and all of the properties within 200 feet of any line of the property which is the subject of the application and showing, to scale, all structures within the area indicating the use of each, and showing the zoning of all the areas depicted, except in the Marine Recreation District the radius map shall be 500 feet. In addition, applications in the "A Residence District" and "CA Residence District" that have non-residential structures or include a proposed change of use to a residential or non-residential use, the radius map shall also be 500 feet. The number of copies of the area map required for each application shall be at the discretion of either Board, through rules promulgate by either Board from time to time.

Section 3. Subsections 250-25 (A)(7) and 250-25(A)(8) are hereby deleted in their entirety from section 250-25 entitled "Permitted encroachments" and subsection 250-25(A)(9) regarding stairs in the front yard setback is hereby renumbered as subsection 250-25(A)(7).

Section 4. The following subsections are added to section 250-108 entitled "Prohibited and restricted uses":

P. In any use district HVAC equipment shall be prohibited in the front yard setback and within five (5) feet of the side and rear property lines. [Added 7-8-2024 by L.L. No. \_\_-2024]

Q. In any use district Generators (permanent or portable) shall be prohibited in the front yard setback and within five (5) feet of the side and rear property lines and shall be restricted to one side yard or the rear yard. [Added 7-8-2024 by L.L. No. \_\_-2024]

Section 5. The following subsections are added to section 250-74 entitled "Restrictions on uses" of Article VIII entitled "MR Marine Recreation Districts (MR)":

N. No sheds or stand-alone structures shall be permitted in the front yard or side yards of a property without a special exception from the Board of Zoning Appeals. The right to maintain any sheds or stand-alone structures in violation of the provisions hereof as a

legal nonconforming use without obtaining a special exception shall terminate by amortization on December 31, 2024. [Added 7-8-2024 by L.L. No. \_\_-2024]

O. The storage of motorized equipment under or south of the boardwalk is prohibited. [Added 7-8-2024 by L.L. No. \_\_-2024]

Section 6. Section 250-118 entitled "Clear-site triangle" is hereby deleted in its entirety.

Section 7. Full Force & Effect.

Except as hereinabove amended, Chapter 250 shall remain in full force and effect.

#### Section 8. Repealer.

All ordinances, local laws or resolutions, or parts of ordinances, local laws or resolutions of the Incorporated Village of Atlantic Beach inconsistent with the provisions of this local law are hereby repealed, provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this local law shall be in addition to other legislation regulating and governing the subject matter covered by this local law.

#### Section 9. Severability.

If any section, paragraph, subdivision or provision of this local law shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this local law as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

#### ATLANTIC BEACH RESCUE UNIT

During June the Atlantic Beach Rescue Unit responded to 35 aided cases – 19 in the Village, 9 mutual aid to Long Beach, 1 water rescue call and a house fire in Lawrence.

#### PARKS AND BEACHES COMMISSION

Four drownings occurred in Rockaway over the July 4th weekend all after hours when lifeguards went off duty. Please never swim when lifeguards are off duty. Village beaches are patrolled every day from 10:00 am to 6:00 pm through Labor Day weekend and several weekends following depending upon the weather. Please remember to adhere to the National Drowning Prevention Alliance Five Layers of Protection including swim competence, learn CPR, designate water watchers, wear a PFD while boating and kayaking and adhere to all home pool regulations.

#### CHIEF LIFEGUARD - DAN MAJIKAS - REPORT

Good evening, I am Dan Majikas, Chief Lifeguard. We look forward to continuing a safe and enjoyable summer this season. We have a total crew of 30 lifeguards, with 24 returning veteran guards, supported by Assistant Chief, Trevor Radin, and we have added a rookie class of 6 new guards. With such a full crew we don't expect any beach closures as we have had the past two seasons. We look forward to continuing our Junior Lifeguards program in a partnership with the Ocean Club, educating our resident kids on ocean safety, learning preventative lifeguarding skills, andk practicing with rescue equipment, hoping to bolster our crew for the future. As always the beaches will be protected from the hours of 10am-6pm 7 days a week, through Labor Day. As you are aware the same rules are in place with surfing designated in certain areas at a safe distance from bathers, fishing is permitted only on the jetties out of our swimming areas. Swimming areas will be marked with red and green flags, and other flags (yellow and purple) may be used to indicate hazardous conditions or marine life.

In these opening weeks, I'm happy to say that I have witnessed our chair personnel and beach attendants building positive relationships with residents and park commissioners. I look forward to another safe and enjoyable summer.

# The Village Garden Report July 8, 2024

We are reaching the midpoint of our garden season and thanks to our dedicated volunteers and garden supporters—things are flourishing

- Thus far, we've been able to make weekly donations of freshly harvested produce to the Long Beach and will continue to do that as the crops come in throughout the season
- In June, we hosted a successful Children's Lady bug release where many children from the neighborhood released helpful Ladybugs into the garden beds as a way of preventing harmful insects from damaging the crops.
- At our monthly volunteer garden-fresh cooking demonstration we enjoyed a brief
  presentation on a program called Teens for Food. This program grows thousands of
  pounds of food each year for use in the surrounding community and schools while
  teaching students valuable lessons in science, agriculture, food justice etc....
- This week our volunteers are getting a guided tour of the Atlantic Beach Water Reclamation District. What we are sending into our wastewater how it gets processed and disinfected
- I'll also be hanging a sign on the garden fence with a QR code that will take you to a link for a New York State Department of Environmental Conservation rewards program of up to \$500 for taking environmental initiatives in your home landscapes.

And Finally- I want to announce/promote The Village Garden's Annual Garlic & Shallot Festival next Wednesday, July 17<sup>th</sup> from 5:30 to 7:30 PM. We sell 4 types of organic garlic and two types of Shallots- all organically grown in our garden. We also have bespoke garden-made products like vinegars, teas, and more for sale. A gigantic and delicious tastings table with garden-fresh goodies to sample and musical entertainment for everyone to enjoy!

It's a huge fundraiser for the garden and more important than ever this year. We appreciate your support.

# Atlantic Beach Cats Report May-June 2024

Atlantic Beach Cats ,Inc. became a 501C3 tax exempt organization in 2004. For those who have never heard about us, we are one of the first communities in the country to form a TNR (trap Neuter Return) program to humanely reduce the feral cat population in our village. We have been in newspapers and magazines, been on a Pet Smart commercial, answered calls from all over the country for advice on controlling the feral cat population, taught our neighboring community of Long Beach about TNR and helped pass a law in the Town of Hempstead that encourages neuter vs euthanizing cats.

Howard, the owner of the Sunny Atlantic Beach Club was there to give a helping hand when a group of volunteers showed up on a chilly morning to let us store our traps in his beach club. Brian Kortis, who worked under the NYC mayor's alliance, came to Atlantic Beach to teach us everything about TNR. Emily, our village clerk, was thrilled to have us start the TNR program because village residents would call the office almost daily to complain about issues with feral cats on their property. Emily doesn't have to deal with that anymore.

Since the start of the TNR program, we have neutered and cared for over 400 cats. Our feeding sites are declining in size due to this program. We have reduced the feral cat population in our village to about 10% of what it was when the program started.

Sadly, two of the feral cats that we have taken care of passed away this past month. They were almost 15 years old, showing that our program is the only proven way to humanely reduce the feral cat population.

So don't forget us. We rely on your donations to fund our work, which mostly consists of food and vet costs for the cats. We also receive an annual stipend from our village, for which we are very grateful.

#### **PUBLIC WORKS**

We've replaced small sections of boardwalk decking behind the Nautilus and continue to fasten loose boards in various locations along with the random replacement of decking boards as needed.

All of the Village beaches are being surf raked routinely as part of our seasonal maintenance and will continue.

Stop bars have been painted on Pacific Blvd and parts of Atlantic Blvd and will continue, parking areas at the beach ends will also be done after pavement patching has been completed.

We've started our seasonal street sweeping around the Village, the seasonal 10-5 parking restriction is in place so please remove your cars from the street so as not to impede the process. The weekly schedule is up on the village website.

Routine landscaping work throughout the village is being performed weekly in most areas.

We've hired a contractor to repair various roads in the village with asphalt, and this work will continue. We've recently repaired a section of the Jefferson Beach end, Montgomery Blvd and Hamilton Ave. We are evaluating other locations to replace with concrete and will be undertaking that work in the coming months.

#### PROCUREMENT POLICY FOR THE VILLAGE OF ATLANTIC BEACH

WHEREAS, Section 104-b of the General Municipal law requires the governing body of every municipality to adopt a procurement policy for all goods and services which are not required by law to be publicly bid, and

WHEREAS, the Board of Trustees has examined the Village's policies and procedures for such procurement and has determined appropriate procedures to comply with this new legislation.

#### NOW THEREFORE BE IT

RESOLVED, that the VILLAGE OF ATLANTIC BEACH does hereby adopt the following procurement policy which is intended to apply to all goods and services which are not required by law to be publicly bid.

#### PROCUREMENT POLICY FOR THE VILLAGE OF ATLANTIC BEACH

1. Every purchase to be made must be initially reviewed to determine whether it is a purchase contract or a public works contract. Once that determination is made, a good faith effort will be made to determine whether it is known or can reasonably be expected that the aggregate amount to be spent on the item of supply or service is not subject to competitive bidding, taking into account past purchases and the aggregate amount to be spent in a single fiscal year. The following items are not subject to competitive bidding pursuant to Section 103 of the General Municipal Law: purchase contracts under \$20,000 and Public Works contracts under \$35,000; emergency purchases; goods purchased from agencies for the blind or severely handicapped; goods purchased from correctional institutions; purchased under State and County contracts; and surplus and second-hand purchase from another governmental entity.

The decision that a purchase is not subject to competitive bidding will be documented in writing by the individual making the purchase. The documentation may include written or verbal quotes from vendors, a memo from the purchaser indicating how the decision was arrived at, a copy of the contract indicating the source which makes the item or service exempt, a memo from the purchaser detailing the circumstances which led to an emergency purchase, or any other written documentation that is appropriate.

- 2. All goods and services will be secured by use of written requests for proposals, written quotations, verbal quotations, or any other method that assures that goods will be purchased at the lowest price and that favoritism will be avoided, except in the following circumstances: purchase contracts over \$20,000 and public works contracts over \$35,000; goods purchased from agencies for the blind or severely handicapped pursuant to Section 175-b of the State Finance Law; goods purchased from correctional institutions pursuant to Section 186 of the Correction Law; purchases under State contracts pursuant to Section 104 of the General Municipal Law; purchases under County contracts pursuant to Section 103(3) of the General Municipal Law; or purchases pursuant to subdivision 6 of this policy.
- 3. The following method of purchase will be used when required by this policy in order to achieve the highest savings:

### Estimated amount of Purchase Contract

\$1,000 - \$2,999

\$3,000 - \$20,000

#### Estimated amount of Public Works Contract

\$1,000 - \$6,000

\$6,001 - \$35,000

A good faith effort shall be made to obtain the required number of proposals or quotations. If the purchaser is unable to obtain the required number of proposals or quotations, the purchaser will document the attempt made at obtaining the proposals. In no event shall the failure to obtain the proposals be a bar to procurement.

- 4. Documentation is required of each action taken in connection with each procurement.
- 5. Documentation and an explanation is required whenever a contract is awarded other than the lowest responsible offeror. This documentation will include an explanation of how the award will achieve savings or how the offeror was not responsible. A determination that the offeror is not responsible shall be made by the purchaser and may not be challenged under any circumstances.
- 6. Pursuant to General Municipal Law Section 104-b(2)(f), the Village's Procurement Policy may contain circumstances when, or types of procurements for which, in the sole discretion of the governing body, the solicitation of alternative proposals or quotations will not be in the best interest of the municipality. In the following circumstances it may not be in the best interests of the Village of Atlantic Beach to solicit quotations or document the basis for not accepting the lowest bid.

a. Professional services or services requiring special or technical skill, training or expertise. The individual or company must be chosen based on accountability, reliability, responsibility, skill, education and training, judgment, integrity and moral worth. These qualifications are not necessarily found in the individual or company that offers the lowest price and the nature of these services are such that they do not readily lend themselves to competitive procurement procedures.

In determining whether a service fits this category, the Board of Trustees shall take into consideration the following guidelines:

- (a) whether the services are subject to State licensing or testing requirements;
- (b) whether substantial formal education or training is a necessary prerequisite to the performance of the services;
- (c) whether the services require a personal relationship between the individual and municipal officials.

Professional or technical services shall include but not be limited to the following: services of an attorney; services of a physician; technical services of an engineer engaged to prepare plans, maps and estimates; services of a certified public accountant, printing services involving extensive writing, editing or art work; programming services for customized programs, or services involved in substantial modification and customizing of prepackaged software.

- b. Emergency purchases pursuant to Section 103(4) of the General Municipal Law. Due to the nature of this exception, these goods or services must be purchased immediately and a delay in order to seek alternate proposals may threaten the life, health, safety or welfare of the residents. This section does not preclude alternate proposals if time permits.
- c. Purchases of surplus and second-hand goods from any source. If alternate proposals are required, the Village of Atlantic Beach is precluded from purchasing surplus and second hand good at auction or though specific advertised sources where the best prices are usually obtained. It is also difficult to try to compare prices of used goods and a lower price may indicate an older product.
- d. Goods or services under \$1,000. The time and documentation required to purchase through this policy may be more costly than the item itself and would therefore not be in the best interests of the taxpayer. In addition, it is not likely that such de minimis contracts would be awarded based on favoritism.
