

**INCORPORATED VILLAGE OF ATLANTIC BEACH

INSTRUCTIONS AND REQUIREMENTS FOR FILING FOR A DEMOLITION PERMIT

The following must be submitted and accepted prior to issuance of a Demolition Permit:

1. A separate application for a Demolition Permit shall be submitted for each building to be demolished. If more than one building or structure is to be demolished on the same premises, the separate Demolition (and Plumbing) Permits secured for each building or structure must satisfy all the requirements relative to such permits.
2. Application shall be made by the owner or lessee, or agent of either, or by the architect, engineer, builder, excavation or demolition company employed in connection with the proposed work. Where such application is made by a person other than the owner, it shall be accompanied by an affidavit of the owner or applicant that the proposed work is authorized by the owner and that the applicant is authorized to make such application.
3. A Certificate of Workmen's Compensation Insurance good for demolition at the subject site.
4. One (1) copy of a survey, showing existing grades of the subject property prior to demolition.
5. An affidavit must be submitted by an architect or engineer (signed and sealed) to verify the absence (or presence) of asbestos. In cases where asbestos is found to exist, demolition permit may not be issued until the asbestos has been removed, and lawfully disposed of, and such certification by a recognized licensed asbestos removal firm has been filed with the Building Department.
6. A letter from LIPA indicating that the electric services to the building or structure to be demolished have been disconnected or have never been installed.
7. A letter from NATIONAL GRID indicating that the gas services to the building or structure to be demolished have been disconnected or have never been installed.
8. A letter from New York American Water indicating that the water service to the premises to be demolished have been disconnected or never been installed.
9. **Chain link fencing or other suitable fencing shall be installed around the property. Fencing shall be installed as to not block the sidewalk**
10. If the building or structure to be demolished is connected to a sewer, a Nassau County Sewer Permit, a Road Opening Permit (Town, County and/or State) and an Incorporated Village of Atlantic Beach Plumbing Permit for the disconnection must be obtained and submitted with the demolition.
11. A separate Plumbing Permit shall be required for each sewer disconnection.
12. An affidavit certifying that all underground wells, basins, cellars or other known voids will be filled with clean fill and that every buried storage tank, including all connections thereto, will be removed and the void filled with clean sand, immediately upon completion of demolition.

13. Nassau County Department of Health Extermination Certificate. The Inspection Certificate expires ten days after issuance.
14. All of the foregoing requirements must be satisfied prior to issuance of a Demolition Permit.
15. Color photographs of all sidewalks, curbs and aprons of subject premises.
16. Person to which Demolition Permit is issued shall notify our Building Inspector at least 24 hours in advance of the actual time scheduled for the start of such demolition.
17. Demolition shall comply with all applicable Village and New York State Uniform Fire Prevention and Building Codes.
18. The total fee for Demolition Permit shall be:

Residential Structures	\$1000.00
Interior	\$500.00
Multiple Residential	\$1500.00
Other residential	\$250.00
Commercial	\$2500.00

(Note: Not required if necessary part of filed alteration permit)

19. All affidavits shall be notarized and all certificates and letters shall be originals.
