PUBLIC WORKS

We are nearing completion of our work for the season of the bike lane and decking. Upon completion, we will proceed with minor repairs and board replacements as necessary and as time allows. The boardwalk will open soon.

We have removed 8 timber piles under the boardwalk and replaced them with new concrete footings and timber supports.

We're continuing with our annual cleaning and grading of beaches and removing the sand fences and plywood walls.

We will soon start on the seasonal cleaning and maintenance of the grass of the village properties and beach ends in the coming weeks. The islands on Ocean Blvd have all been cleaned up and mulch replaced. The plantings should soon be in bloom, and some plantings will be replaced.

Beach gate lock combinations will be changed by May 15th. Come into the main office to obtain the new code or ask for it when obtaining your beach pass or parking decal.

The drainage improvement project on Bay Blvd from Albany to Broome begins later this week or early next week. Expect daily road closures in this area during workday. Please use alternate routes.

Fencing repairs and replacement at the tennis center south courts will be starting this week.


